VA CLAIMS

The legal Team at Capovilla & Williams represents clients in all types of VA claims, including:

- ORIGINAL CLAIMS** This involves filing the VA Form 21-526EZ along with all VA and private medical records and supporting statements.
- INCREASED CLAIMS** Provides for an increase in disability rating and compensation when a previously approved claim worsens.
- SECONDARY SERVICE-CONNECTED CLAIMS** Involves additional compensation for a new disability that is linked to an existing service-connected benefit.
- SPECIAL CLAIMS** Provides for additional benefits such as a specially equipped vehicle due to a decrease in mobility after surgery.
- PRESUMPTIVE CONDITION CLAIMS** Under new legislation, the PACT Act expands benefits for Veterans experiencing symptoms related to exposure to toxic substances.
